## **ASSESSMENT YEAR-IN-REVIEW**

Its been a great year for assessment at UF! Establishment of the standalone Institutional Research and Assessment Office (IR&A) on campus has ushered in new energy and focus on continuous improvement. Strengthening data consistency and compliance was a main focus this inaugural academic year. Enhancements included standardizing data submitted to national and regional required reporting entities including IPEDS, ODHE, HLC, AICUO, and NCAA. Office staff have tackled and fulfilled 50+ data requests for projects, grants, and accreditation. From successfully launching the Watermark Course Evaluations and Surveys product to implementing the HEDS (Higher Education Data Sharing Consortium) Diversity and Equity Campus Climate survey, we've also streamlined processes and introduced new assessment opportunities. The coming academic year will feature expansion into new assessment territory, including launching the HEDS New Student Survey and the transition of Taskstream (AMS & LMS) to the IR&A administrative umbrella. With more changes and initiatives to come, stay tuned for updates and trainings throughout the coming months.

## CURRICULAR ASSESSMENT COMMITTEE

The Curricular Assessment Committee is excited to share that the culmination of the last few years' work on updating the curriculum assessment process is coming to fruition. In the Spring of 2022, Faculty Senate approved the committee's proposal for the new process. This means beginning in 2022-2023, programs will be utilizing a new workspace, using the new question prompts to submit program information, submitting on a three-year cycle, and report on the new outcomes. In addition, we have added a remediation process (as needed) for any program needing additional support or fine tuning of their assessment practices.

The committee has been hard at work this summer to make this transition as smooth as possible. We are in the final stages of building the Taskstream workspace and vetting the submission process, and will make the workspaces available to you as early as possible.

What does this mean for you?

- In the coming weeks programs will be notified of their newly assigned submission cycle.
  - Orange submitters = 22/23 academic year
  - Black submitters = 23/24 academic year
  - White submitters = 24/25 academic year
- Education and support sessions will be offered.
  - Back to School sessions
  - Sessions sponsored through CTE during the semester
  - One-on-one committee pair support between September-November
  - Help Sessions in January
- Orange Submission due date = January 27, 2023

Reminder of the New Outcomes:

- Undergraduate Programs will report on a Knowledge, Skill, Disposition, and Experiential Learning
- Graduate (and Professional) Programs will report on a Knowledge, Skill, Disposition, Experiential Learning, and Research

As a committee we are very proud and excited for this new process. It is our hope that you will find this to be a less stressful and more meaningful process to promote continuous improvement and support of best practices in curricular assessment. We ask for your patience during the transition and look forward to receiving constructive feedback from the university community.

## **GENERAL EDUCATION (CORE+) ASSESSMENT**

Hello, UF Community and welcome to the 2022-2023 Academic Year!

As Committee Chair, I am excited to welcome a number of new faculty onto the General Education Committee. It's always nice to bring new voices and new ideas into the process. So, if you haven't checked recently who your College Representative(s) on the GE Committee are, make sure to do so and reach out to them with questions or concerns.

With regards to General Education, we are always in the mindset of "continuous improvement." The GE Committee would love to see more engaging and interesting courses incorporated into the curriculum. In addition to adding new courses into the CORE+ curriculum, the Committee also likes to see areas reflecting upon the assignment used for assessment. Thus, there's a process to revise the assignment(s) for a CORE+ course. Please be watching for new CORE+ submission and CORE+ assignment revision invitations throughout the year.

The 2021-2022 academic year was full of a lot of great highlights as it pertains to General Education:

- We reached 76% and 75% participation rates in student assessment submissions (within the LAT side of Taskstream) for seats in CORE+ courses in the Fall and Spring semesters respectively.
- Undergraduate Council approved additional courses within the CORE+ Curriculum. For a full, updated list, follow this link on the University website: https://www.findlay.edu/intranet/core-approved-courses.
- The GE Committee placed special attention on improving the experience of the AMS CORE+ assessment process. This improved area within Taskstream includes more detailed directions, specific examples of high-quality submitted sections to help "point persons" with their annual submissions, and helpful templates to aid in the AMS submission. Throughout this assessment process, the Committee wants to emphasize pedagogy and learning outcomes: how will the data and observations made during the year lead to improved teaching? Please keep that central question in mind as you work through your AMS space.
- Additionally, Committee members reviewed the AMS CORE+ course submissions performed by faculty during the previous year. If you were the "point person" responsible for a course review, check your AMS space in Taskstream to look at the scoring and feedback.

Finally, we want to hear from you! Please reach out to me or your GE Committee College Representative(s) if you have questions or concerns with all things related to GE. Don't forget that the University now has dedicated space on the website for assessment. ## **NON-INSTRUCTIONAL ASSESSMENT**

NIA would like to thank all participating areas for their time and effort in completing this year's assessment. As many of you noticed, there were a few changes in the assessment that we hope will better align with the University's strategic goals and help facilitate benchmarking within your divisional goals while still focusing on the strengths of each noninstructional area and challenges faced. Moving forward, NIA will be working to establish ways to better support the reporting divisions. One option we are looking into is offering yearly development training/workshops that focus on 1-2 most common challenges reported by the divisions. We hope to be able to partner with staff, faculty, and University partners to help facilitate these development opportunities.

This year NIA saw 98% of units reporting out for the 2021-2022 year. The committee has been working on reviewing the assessment data as well as identifying several overall common themes. More information is forthcoming from the Spring 2022 review of data, as the committee moves into Fall 2022 this information will be shared with Dr. Fell and the Cabinet.
