

# EARLY ASSURANCE AGREEMENT BETWEEN THE UNIVERSITY OF FINDLAY AND LAKE ERIE COLLEGE

This Early Assurance Agreement ("Agreement") is entered into between The University of Findlay (UF) on behalf of the University's College of Pharmacy and Lake Erie College (LEC), collectively referred to as the "Parties," and is effective on the date of final signing.

WHEREAS, a central element of UF's College of Pharmacy's mission endeavors to provide pharmacy education in a diverse, supportive, student-centered environment that engages a collaborative practice of pharmacy care and related health disciplines; and

WHEREAS, LEC has the responsibility to educate and facilitate appropriate career pathways for students enrolled in its undergraduate programs of study; and

WHEREAS, the Parties have a shared interest in providing guidance and improving access for qualified students to UF's Doctor of Pharmacy degree program;

NOW THEREFORE, it is agreed that UF and LEC agree to establish a 3+4 program for qualified students as outlined below, beginning with the 2015-2016 academic year in which, after three years' academic work (to include 120 semester hours) at LEC, up to seven (7) LEC students per year will be eligible for direct admission to UF's Doctor of Pharmacy degree program.

#### I. Formal Agreements

The Parties may establish additional formal agreements that may more specifically set forth the rights and obligations of the Parties.

## II. Student Eligibility for Consideration of Participation in 3+4 Program Beginning in the 2015-2016 academic year, LEC will encourage a pool of highly qualified

students to seek admission to the P3 year of UF's Doctor of Pharmacy program. Admission to the program will be open only to those applicants who enter as freshmen and complete all three years of their undergraduate work at LEC. Transfer students and those who do not matriculate directly into the LEC Accelerated Chemistry Program as incoming freshmen will not be eligible.

#### III. <u>Prerequisites and Admission Requirements</u>

UF will identify acceptable prerequisites from LEC to include:

- a. Participation in the LEC Accelerated Chemistry Program and attainment of a B.S. in Chemistry (see Appendix A )
- b. Fulfillment of all admissions requirements and standards as defined by UF for admission into the first professional year (P3 year) of UF's Doctor of Pharmacy degree program (see Appendix B)



#### IV. Early Assurance Program (EAP) Timeline

At the completion of Year 2, EAP students who meet UF's College of Pharmacy admission criteria (Appendix B) may apply to UF's Doctor of Pharmacy degree program as a transfer student. Each applicant shall also schedule an interview through UF's College of Pharmacy admissions coordinator. Admission into the program is highly competitive, and only seven of these qualifying EAP students shall be offered admission into UF's College of Pharmacy. Admission shall be contingent upon successful completion of all academic and non-academic requirements for entry into the first professional year (P3 year) of UF's six year Doctor of Pharmacy program.\* At this time, students offered early assurance of admission will be required to pay an enrollment deposit to UF's College of Pharmacy. The enrollment deposit must be paid by June 1st of the summer between year 2 and year 3 at LEC. If the enrollment deposit is not received by this date, a seat in UF's College of Pharmacy cannot be guaranteed. Accepted LEC students will then enter UF's Doctor of Pharmacy program as a first professional year (P3 year) student at the completion of year 3 at LEC.

\* If there are additional LEC students who also meet UF's College of Pharmacy admission requirements they will be considered for admission only if there are seats open in the first professional year (P3 year) of UF's six year Doctor of Pharmacy program.

#### V. Marketing and Recruitment

Upon execution of this agreement, each party to it may publicize the program.

LEC, for the purposes of marketing and recruitment, in any instance in which The University of Findlay's name or trademark (including names of academic programs departments, athletic teams or any recognized club and organization affiliated with The University of Findlay) is used by non-UF organizations to market the non-UF organization, any and all messages related to The University of Findlay may not be used without prior expressed written permission from the Office of Marketing and Communication. To obtain this permission, submit a written request, along with print-ready proofs via email (preferable) to the Office of Marketing and Communication at jenkinsr1@findlay.edu.

LEC, for purposes of marketing and recruitment, will allow The University of Findlay's Office of Admission staff and faculty representatives to visit campus twice an academic year (once in the fall semester and once in the spring semester) to meet with prospective students to discuss the College of Pharmacy, entrance requirements, financial aid, and other related enrollment information.

LEC, for the purposes of marketing and recruitment, will allow The University of Findlay's Office of Admission to conduct an annual visit to campus, to provide a review of The University of Findlay's Pharmacy Program requirements and updates to members of the Office of Admission from LEC and their faculty representatives. This annual update should be scheduled for July.



LEC shall have the exclusive authority to determine any entrance criteria for students seeking admission to LEC who fail to satisfactorily complete the admission requirements to UF's Doctor of Pharmacy degree program.

Either party to this agreement may cancel it by submitting a Notice of Termination to the other party with two academic year's notice; however, any student who is enrolled in the Accelerated Chemistry Program at LEC at the time of said cancellation shall be entitled to any rights or privileges provided under the terms of this agreement and the same will be honored by both LEC and UF. Both parties have the right to amend this agreement at a future date to include other programs as deemed appropriate.

#### **APPENDIX B**

As of the 2014-2015 academic year, The University of Findlay (UF) College of Pharmacy has the following requirements for entering the first professional (P3) year in the Doctor of Pharmacy Program. Each student will be evaluated on an individual basis to determine his or her eligibility for P3 entry based on academic transcripts. If a student has already completed certain course requirements from The University of Findlay College of Pharmacy P3 (first professional) year, consideration may be warranted to allow for unfinished pre-professional course work to be completed during the P3 year.

- Cumulative college GPA: ≥ 3.0
- Didactic Requirements: A grade of "C" or better in each of the following courses:
