COMMUNITY SUPPORT

- Current mayor is 65+ so he understands this age population
- Older adults can work/volunteer at the New Washington library
- Older adults can play in the community band

HOUSING

- No retirement communities in New Washington
- Bucyrus, Ohio: Ridgewood Senior Villas: 14 miles away: adults 55+, attached garage, private entry, appliances included, emergency pull station, community room, exercise room, garden for each resident, pet friendly, 24-hour maintenance, onsite management, walking path, and activities
- Crestline, Ohio: Miller-Valentine Affordable
 Housing (MVAH) Faith Community Housing: 17
 miles away: adults 55+, community events, pet
 friendly, attached garage, private porch, on-site
 management, stair-free living, walking paths,
 gardens, and safe community

TRANSPORTATION

- Crawford County Council on Aging Specialized
 Transportation: adults 60+ or individuals with
 disabilities, M-F 6am-5pm, door to door services
 for appointments, groceries, salons, etc.,
 wheelchair lifts, trained drivers, out of county trips
 available, \$2-\$4 donation request as passengers
 board, but no required payment
- Seneca-Crawford Area Transportation: curb to curb service with driver assistance if necessary, wheelchair lifts, schedule 48 hours in advance for in county trip and 72 hours in advance for out of county trip, safe, reliable, and efficient system

SOCIAL ENVIRONMENT

- Crawford County Council on Aging in Bucyrus, Ohio (15 miles): Activities including trivia, painting classes, pizza with movie nights, wood carving, crafts, bingo, chair yoga, blood pressure checks, card making, ice cream socials, etc., congregate meals served with requested but not necessary \$4 donation
- Golden Gem Senior Center in New Washington
- Dutchtown Dillies Red Hat Society in New Washington

OUTDOOR SPACES & BUILT ENVIRONMENT

- Community pool, decent sidewalks throughout town, easy to cross streets, senior center, library, gazebo with benches for the town band to play, high school track open to community, and benches around town
- No age-friendly park and historical society museum is up a lot of steep stairs

HEALTH & WELLNESS SERVICES

- Young Chiropractic Inc.
- Brent Fissel DDS dentist office
- Mercy Health primary care doctor's office
- Avita Health family medicine doctor's office
- Nearest hospitals: Willard, Ohio Mercy Health Hospital (13 miles), Bucyrus, Ohio Avita Health System Hospital (14 miles)
- Small walking group at the high school indoor track
- Ambulance system out of Bucyrus, Ohio (14 miles)

CONCLUSION

After analyzing these six aspects of my community of New Washington, Ohio I would say that is is not the most age-friendly community. It is a very small town so older people would not have as much access to needed services. New Washington has some of the aspects met, but I do not feel that there are enough within the community.
