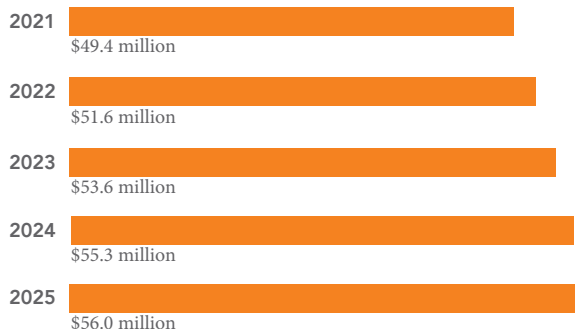

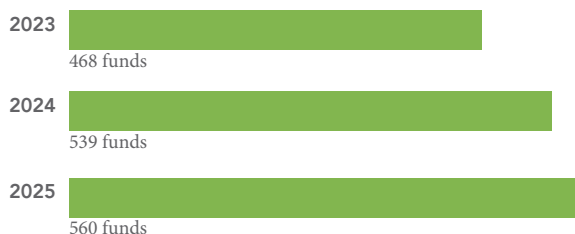
Giving by Constituency
