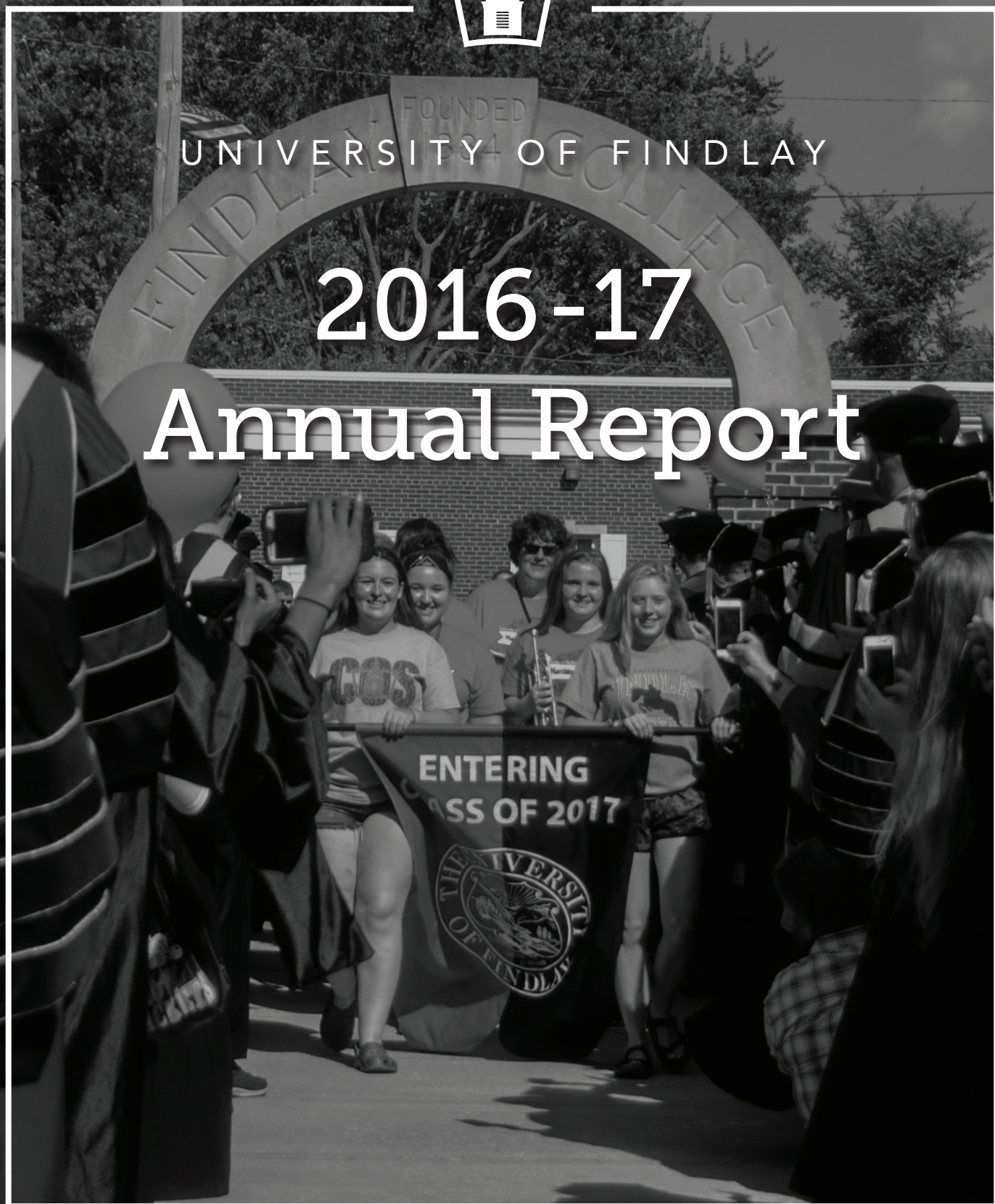

Top UF News Stories for 2016-17

As UF's elegant Center for Student Life and College of Business took shape during the 2016-2017 academic year, transformational academic endeavors and other impactful activities continued to happen as well. This time period proved to be exceptionally rewarding for those on campus and the surrounding community. **Here are some highlights, in no particular order:**

- 1 Center for Civic Engagement** – Announced in December 2016, the CCE, which is housed in the Center for Student Life, is a community endeavor forged by UF leaders, government and charitable organizations. It supports existing coalitions in their efforts to address the region's most complex social issues ranging from lack of affordable housing to the substance abuse scourge.
- 2 Credo** – This past spring, UF hired Credo to provide master planning guidance. The use of space, aesthetics and overall function is being examined so that the University can provide a more cohesive campus experience for everyone who learns, visits, works and lives on campus.
- 3 Mazza Museum Traveling Exhibits** – The Mazza Museum is increasingly a source of UF pride as it expands its outreach throughout the state and nationally. Exhibits in cities such as Washington, D.C., Columbus and Cincinnati have provided more opportunity for the museum to increase its literacy education by making available outside of Findlay part of its vast collection of original artwork from children's books.
- 4 Fridays at Findlay** – The University launched this executive speaker series to offer the campus and community valuable insight from professionals who have achieved great success. The breakfasts have thus far featured individuals such as Toledo Zoo Executive Director Jeff Sailer; UF alumnus and former Chicago Bears defensive back Harold Jones-Quartey; and a panel of CEOs from CSX Corporation, Garner Trucking Inc., Marathon Petroleum Corporation and Ohio Logistics.
- 5 Sweet Sixteen** – The men's basketball team made it to the "Sweet 16" finals of the NCAA Division II Midwest Regionals! The Oilers fell to the Bellarmine Knights, but fans were excited to follow the team as they gave it their all throughout the season and all the way to the tournament in Louisville, Kentucky.
- 6 Browns Summit** – In September 2016 UF hosted the second Browns Edge Career Development Summit. Several professionals from the organization offered tips to students about the value of starting from the bottom of the career ladder, what employers are looking for during job interviews, and how internship experience during college can help establish one's career.
- 7 "The Addams Family"** – Creepy and kooky, members of "The Addams Family: The Musical" graced the stage in February. Featuring elaborate costume and makeup design, inventive scenes and a talented cast, the production at the Marathon Center for the Performing Arts provided hours of memorable entertainment for the campus and community.
- 8 Faye Newman Nursing Scholarship** – Faye Newman '70 gifted \$500,000 to UF to support scholarships for Nursing Program students. Newman was a registered nurse for 50 years, and views her donation as a way to show future nurses that others care about their education.
- 9 Doctor of Occupational Therapy** – UF will begin offering a Doctor of Occupational Therapy degree, which will prepare students for practice as well as leadership roles and advanced positions. Students may begin applying in fall 2018, and the first cohort will begin classes in June 2019.
- 10 The Well** – The University's second annual theology camp for high school students was offered in July 2017. Providing nondenominational, Christian-focused content, the institute focused on participants delving into concepts about faith, life and vocation, and how those intersect.

Grant Funding Furthers UF's Mission



The University of Findlay received more than \$300,000 in grants during fiscal year 2016-17, which are funding a variety of important initiatives such as campus safety, vocational training, and addressing the region's most pressing social concerns.

A \$40,000 grant, renewable for a maximum of five years, was received from the Findlay-Hancock County Community Foundation for new Center for Civic Engagement (CCE) operations and executive director salary. Located within UF's new Center for Student Life, the CCE, led by Executive Director Leigh Esper, unites organizations and individuals to tackle problems such as transportation, literacy, mental health and substance abuse.

Other grants received include \$32,505 from the Network for Vocation in Undergraduate Education, administered by the Council of Independent Colleges with support from the Lilly Endowment Inc., to enable students to focus more on spiritual inclusivity as they pursue their professional and personal goals. The Ohio Department of Higher Education gave \$10,000 to UF's OC3 (Oilers Changing Campus Culture) for continuing proactive efforts regarding preventing dating violence, domestic violence, stalking and sexual assault. The ODHE also awarded \$3,500 in Choose Ohio First scholarships for incoming, selected students intending to study computer science, logistics and supply chain management, environmental, safety and occupational

health, and STEM (science, technology, engineering and math) fields. The Ohio Humanities provided \$4,030 for English and communication professors Christine Denecker, Ph.D. and Megan Adams, Ph.D., and Hancock Historical Museum Director Sarah Sisser to collect additional narratives for the Ohio Farm Stories project.

Other grants included:

- \$1,000 from the Ohio Department of Education to host Northwest Ohio higher education professors in meetings regarding K-5 curriculum improvement.
- \$3,500 from the nccPA Health Foundation to conduct community outreach on oral health and to combine content with Physician Assistant curriculum.
- \$7,500 from the Institute for International Education to provide six students with study abroad scholarships.
- \$5,000 from the American Foundation for Pharmaceutical Education for Christopher Stang's research under the supervision of Ryan Schneider, Pharm.D., Ph.D.
- \$1,600 from Baxter Pharmaceutical for the College of Pharmacy's Pharmacy 101 Program.
- \$479 from Beta Beta National Biological Honor Society for research conducted by students Chris White and Erin Barrett.

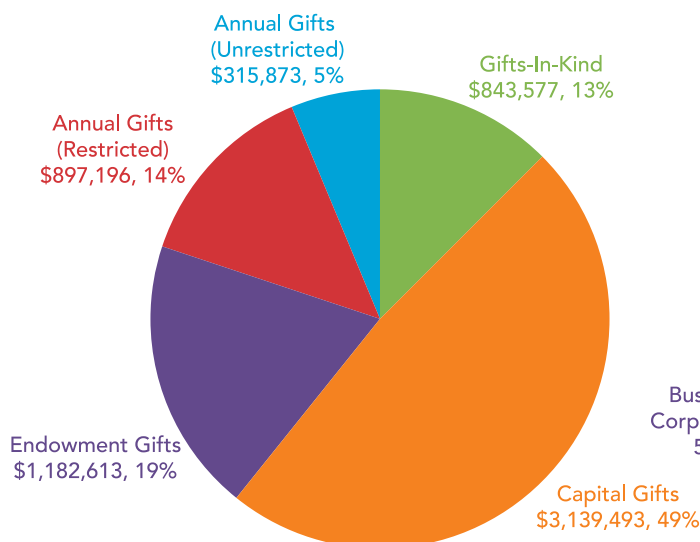

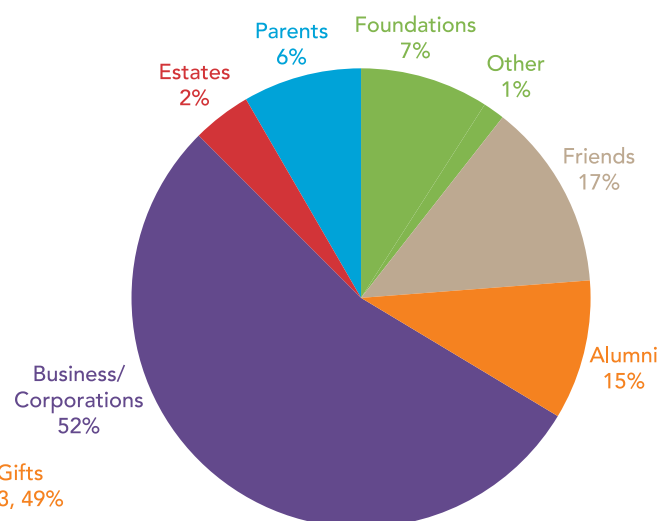

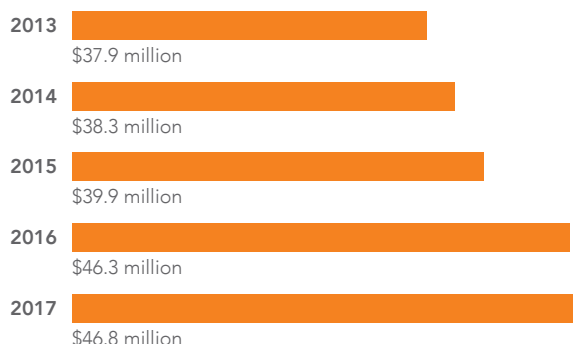
Giving by Gift Category



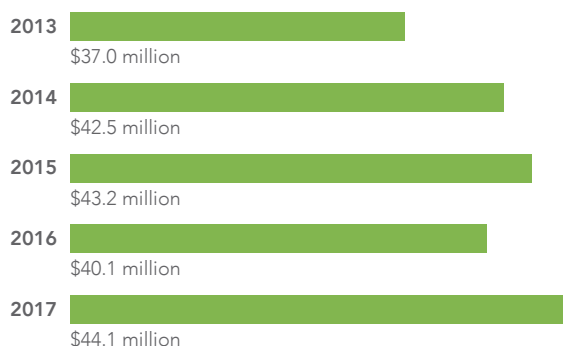
Giving by Constituency



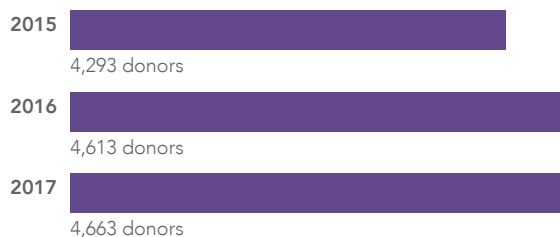
Institutional Financial Aid

New Endowed Funds 2016-17

The following funds became fully endowed during the 2016-17 fiscal year.

Athletic Department Academic Resource Discretionary Fund
