Federal law requires that a student provide documentation to a financial aid administrator to confirm the information reported on the FAFSA prior to aid being disbursed. The Office of Financial Aid will compare your FAFSA with the information on this worksheet and other required documents. If there are differences, your FAFSA information will be updated. You must complete and sign this worksheet, attach any required documents, and submit these forms to The Office of Financial Aid. C. STUDENT INFORMATION TO BE VERIFIED: PROVIDE INFORMATION UNDER 1 OR 2 BELOW.

1. TAX FILERS: COMPLETE THIS SECTION IF THE STUDENT AND SPOUSE FILED OR WILL FILE A 2022 IRS INCOME TAX RETURN(S).

Check one box below:

- The student has consented to their Federal Tax Information (FTI) to be transferred directly from the IRS into the student’s FAFSA.
- The parents have not consented to their FTI to be transferred and instead will provide the school with a **2022 IRS Tax Return Transcript(s) or a signed copy of the 2022 income tax return and applicable schedules.** ****If the parents filed separate 2022 IRS income tax returns, the 2022 IRS Tax Return Transcripts or a signed copy of the 2022 income tax return and applicable schedules must be provided for each.**

A 2022 IRS Tax Return Transcript may be obtained through:

- **Get Transcript by Mail** – Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript by Mail." Make sure to request the "Return Transcript" and NOT the "Account Transcript." The transcript is generally received within 10 business days from the IRS’s receipt of the online request.
- **Get Transcript Online** – Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript Online." Make sure to request the "Return Transcript" and NOT the "Account Transcript." To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2) a text-enabled mobile phone (pay-as-you-go plans cannot be used) in the user’s name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript displays online upon successful completion of the IRS’s two-step authentication.
- **Automated Telephone Request** – 1-800-908-9946. Transcript is generally received within 10 business days from the IRS’s receipt of the telephone request.
- **Paper Request Form** – IRS Form 4506T-EZ or IRS Form 4506-T. The transcript is generally received within 10 business days from the IRS’s receipt of the paper request form.

2. NON-TAX FILERS: COMPLETE THIS SECTION IF YOU WILL NOT FILE AND ARE NOT REQUIRED TO FILE A 2022 INCOME TAX RETURN WITH THE IRS.

Check the box that applies:
